## **Introduction to Mass Communication**

#### **Course description**

**MCOM 1:** This course is a comprehensive survey of mass communication and the interrelationships of media with society, including history, development and trends in the digital age, including analysis of newspapers, magazines, television, radio, online media, public relations, advertising and photojournalism. Students discuss theories and effects, economics, technology, law and ethics, global media, media literacy, and social issues, including gender and cultural diversity. The impact of mass media in a free society is also examined. The course also addresses controls on the media, including media law and ethics. The constitutional basis for a free press is explored. (UC, CSU, C-ID JOUR 100)

## Grading

**Thirty percent** will be based on prewrite and activity assignments and chapter quizzes. The prewrites will serve as introductions to the papers. The activity assignments serve as a fun break to the semester monotony. These assignments will be turned in on *Canvas*. The quizzes will be on each chapter covered in the course.

**Twenty percent** of the final grade will be based on two writing assignments, one connecting a mass communication philosophy to the larger world and another exploring an ethical issue. These papers will be turned in on turnitin.com (Links to an external site.)Links to an external site.

Twenty percent is based on discussions.

Thirty percent will be based on the midterm and a final. The final will not be cumulative.

Grades ARE NOT CURVED in this course.
